Accepting and changing the Terms and Conditions

You must read and accept these Terms and Conditions before finalizing your order. By purchasing through our webshop, you accept the document's provisions, and the Terms and Conditions form an integral part of the contract between you and the Seller.

The Seller is entitled to change the provisions of these Terms and Conditions in compliance with the relevant legal regulations. Any amendments to the Terms and Conditions are valid from the time they appear on the website. Any changes will not affect existing contracts (i.e. confirmed orders).

Language and form of the contract

The language of the contracts covered by the Terms and Condition is Hungarian.

Contracts do not qualify as written contracts since the Seller does not file them.

Complaints

Unless otherwise provided by a directly applicable act of the European Union, the Seller shall reply within 30 days.

Correction of data entry errors - Responsibility for the accuracy of the data provided

During the order, you have the opportunity to change the data you have entered before the order is finalized. Please note that it is your responsibility to ensure that the information is entered accurately, as the product will be billed or shipped based on the information you provide. The Seller excludes its liability for fulfillment based on inaccurate data entry.

Procedure in case of an incorrect price

It may be that an incorrect price is on the website (e.g., due to a technical error). In case of an incorrect price, we cannot accept the order at the incorrect price, and we are not obliged to sell the product at the incorrect price. No contract will be concluded between us in case of bidding at the incorrect price. If you make an offer at an incorrect price, the system will automatically confirm it, but this is not an acceptance of the offer. If you make an offer (order) at the incorrect price, the Seller's employee will draw your attention to the correct price and may offer to conclude a contract at the correct price. You are not obliged to make an offer and enter into a contract at the correct price instead of the incorrect price. In this case, no contract is concluded between the parties.

Steps to order

We accept orders on the website only from natural persons. Customers with a tax number can place their order in a message sent to info@destroycovidgame.com.

In the "Buy" section, it is possible to select the products and specify the quantity you want to buy (the amount is limited that can be purchased in one order). You also can enter a coupon code. After selecting your country and accepting the Terms and Conditions, you can choose between credit and debit card, and PayPal online payment options.

When selecting the credit and debit card option, you must enter your name, email address, telephone number, shipping address, and you can enter notes to the delivery service, or a billing address other than the shipping address. By clicking on the "Pay" button, you will be

redirected to the Barion's page, where you can pay for the purchase by entering your credit or debit card details or logging into your Barion account. After payment, Barion will redirect the customer back to the website, and in case of successful payment, you will receive a confirmation by email.

Online bank card payments are executed via the Barion system. The merchant does *not* get and store bank card data. Barion Payment Inc., the provider of this service, is an institution under the authority of the Central Bank of Hungary, its license number is: H-EN-I-1064/2013.

Selecting the PayPal option will display the PayPal button. By clicking on the PayPal button, the Buyer will be redirected to the PayPal page in a pop-up window where you can log into your PayPal account to settle the amount of the order.

Conclusion of the contract

The information provided on the website does not constitute an offer by the Seller to enter into a contract. In the case of orders within the scope of the Terms and Conditions, you qualify as a bidder, and the contract is concluded when the Seller accepts the bid.

You have the opportunity to place an order at any time. In case of successful payment, automatic confirmation will occur; however, this does not mean acceptance of the offer by the Seller. The contract is concluded by the acceptance of the Seller - you will be notified separately within three working days from the submission of the order. If the order can be delivered immediately, to reduce the number of letters, you may receive a confirmation of delivery - this implicitly indicates acceptance of the offer and the conclusion of the contract.

Deadline for completion

The general delivery deadline for the order is three working days from the confirmation of the order. In the case of products purchased in advance, the delivery deadline is the value stated in the product description. This deadline refers to the delivery of the products to the delivery service and does not include the delivery duration.

The deadline is indicative, but deviations from it will always be informed by email within the deadline. In that case, the Buyer can withdraw from the contract, in which case the amount paid will be refunded immediately. By accepting Terms and Conditions, you acknowledge that the Seller expressly excludes its liability for extending the deadline.

Disclaimer

We make every effort to avoid this; however, some products on the website may not be in stock. We reserve the right to reject orders partially or fully. Partial fulfillment can only take place after consultation with you. The purchase price of the rejected products will be refunded to you on the day the order is rejected.

Refund

When refunding bank or debit card payments, the Seller does not influence the actual refund date. It is worth inquiring about the status of the process with the payment service provider or the bank issuing the card.

Payment methods

There are two payment methods to choose from:

- PayPal
